WORD FROM THE PRESIDENT AND THE CHAIRMAN OF THE BOARD

Being a member of AQCS made sense in October 2018, when the Quebec population brought to power a new government, in a hurry to transform school boards. In the aftermath of the election, your Association was proactive, forwarding your concerns to the Minister of Education and Higher Education, Jean François Roberge. The AQCS Professional Boards have enabled us to build solid arguments, particularly with regard to the optimal management of educational services as well as school construction and renovation projects.

Beyond the provisions that will guide the future school service centers and the governance model that will be retained, we already know that these changes will require agilty. The AQCS will be on the front line to make your voice heard, and to equip you for these changes.

Our 2018-2019 Association Calendar has been busy: in addition to public affairs, we have been working on the upcoming talks on the **renewal of our terms of employment**, as well as on the issues raised by our classification plan. We also adopted **new general regulations** for the AQCS, including a governance model where Mr. Jean-François Parent became President and Chief Executive Officer. Not to mention an increased offer of **development** sessions and management training, through inter-associative partnerships.

During the recent election period, the AQCS positioned school executives as "experts for success". Let's not stop cultivating this conviction. Let us be proud to convey our vision and our field experience, which contribute, beyond any doubt, to the educational success of students.

AQCS achievements for 2018-2019 in brief:

- Ongoing support to members in labour relations
- Monitoring and concerted actions on the right to collective bargaining for managers
- Development of a Web application for executive skills development

CHANGES IN GOUVERNANCE

On May 3, 2019, at an Extraordinary General Meeting, our members adopted a new version of the general regulations of the AQCS. This important project, anchored in our 2017-2020 Strategic Plan, came to fruition after several stages of work and consultation.

Objectives of the revision of general regulations

- Review our governance (including changing the role of Board, the Chairman of the Board and the CEO)
- Consolidate the mandate of the General Council and the General Assembly
- Increase the efficiency of the Board, including the creation of three dedicated committees: Finance, Governance and Strategy (with new procedures for the election of directors)
- Adapt the general regulations to contemporary developments in our associative life

Adoption Stages

- Year 2017-2018: Board reflects on the revision of general regulations
- March 15, 2019: Proposed amendments made to the General Council
- March 27 to April 12, 2019: On-line consultation of members, including an explanatory video
- April 16, 2019: On-line question and answer session for members
- April 18, 2019: Last modified version sent to members
- May 3, 2019: Extraordinary General Meeting, in simultaneous webinar, with adoption of general regulations

Summary of changes made:

- Jean-François Parent, Executive Director, becomes President and Chief Executive Officer. His role in representation and public affairs is growing, as he is now the spokesperson for the AQCS. Mr. Parent will also have greater accountability to the Board.
- Rémi Asselin, Chairman, retains his position with respect to the Board of Directors.
- The General Assembly will be asked to vote, on the recommendation of the Board, on the renewal of the members' national working conditions and to set the AQCS contribution rate.
- The General Council should be consulted by the Board before the adoption of AQCS policies and on the main orientations when renewing the national working conditions of the members.
- Three committees were set up to support the Board: Finance, Governance and Strategy.
- New election procedures for directors were rolled out for the June 2019 elections. The Governance Committee submitted suggestions for nominations received.



LABOUR RELATIONS

Section presidencies: much appreciated initiatives

Welcome day for new Section presidents

On November 1, 2018, during AQCS proceedings, the Labour Relations Department held a welcome day for the new Section presidents. They were able to learn more about the services of the AQCS, their responsibilities as presidents,

the administrative and legal frameworks applicable to their role as well as the working conditions of executives. In addition, role-play exercises allowed them to test their knowledge. The update of a practical guide on the roles and responsibilities of Section Presidents was presented on this occasion.



Training on amendments to the QPP

Section presidents were invited to a half-day training session on the changes to the Quebec Pension Plan (QPP), which came into effect on January 1, 2019. Ms. Nadyne Daigle, Executive Director of the *Regroupement des*



associations de cadres en matière d'assurance et de retraite (RACAR), presented the various applicable amendments and their implications for coordination with the Pension Plan for Management Personnel (PPMP)

Outreach of Sections on the Web





Assessment of the quality of support services for labour relations

In the interest of continuous improvement, a short survey was prepared for members who had dealings with the Labour Relations Department to gather feedback on their experience. The 103 members who contacted the department team between January and April 2019 were invited to respond to the survey. Of these, 51 members participated in the survey.

Evolution of group insurance and pension plan files

In the area of group insurance and pension plans, several files have remained pending development by the Treasury Board Secretariat (TBS):

• Group insurance plan for retirees

Recall that discussions about the future of the group insurance plan for retirees began in October 2016. As a result of consultations conducted, more than 80% of the association's executives voted in favor of abolishing the plan because of the exorbitant cost of annual premiums. Unfortunately, subsequent discussions with retirees did not lead to a consensus, the latter opposing the termination of the regime.

• Return-to-work of retired executives

Through RACAR, since June 2018, the AQCS has been asking for a review of the return-to-work rules for retired executives to allow some flexibility without putting the pension plan at risk. It was only in the spring that discussions began on this subject, which continued during the summer. An outcome in this file is expected in autumn 2019

• Working committee on the issue of RREGOP-PPMP transfers

Several amendments have been made in recent years to the provisions of the Pension Plan for Management Personnel (PPMP) to ensure financial health.

Despite the positive effects of these changes on the executive pension fund, the issue of RREGOP-PPMP transfers has not been resolved. Also, in the longer term, the future of the plan remains compromised because of the costs and the maturity effect generated by RREGOP-PPMP transfers.

A joint working committee, comprising representatives of the management associations and the TBS, was set up with the mandate to explore viable and sustainable solutions for the PPMP. The work of the committee is expected to continue over the next year. To be continued!

Work of the Labour Relations Committee

The Labour Relations Committee brings together members appointed annually at the June meeting of the General Council. The mandate of the committee is to identify, validate and prioritize collective labour relations files. During 2017-2018, the committee met on March 14, 2019 and June 13, 2019. The committee's main topics of discussion were as follows:

- Update of the classification plan
- Challenges of the Pension Plan of Management Personnel (PPMP)
- Group insurance for active managers and retirees
- Return-to-work of retired executives

PROFESSIONAL DEVELOPMENT

New Web Application

The Professional Development Department of the AQCS has set up a new Web application allowing school executives to assess their skills on a continuous basis and to be advised on the training or resources most suited to their needs. An official launch was organised in Quebec City and Montreal in September 2019.



Customized training offer

Several management courses were on the AQCS Calendar in 2018-2019. Thanks to our inter-associative partnerships, and always keen to meet the needs of our members, we have organized diverse activities, either by webinar or in the classroom.

Results obtained during the various evaluations showed a very high degree of satisfaction on the part of the participants. In fact, these activities not only promote the development of new skills but also contribute to sharing expertise and practices. By co-organizing these training sessions with our partners, we generate savings, can hold activities in the regions and present a greater number of distance learning courses.

A day for future managers

In collaboration with the *Association des cadres des collèges du Québec*, the AQCS held two days of training for future managers in January and May 2019. These activities brought together some 40 professionals, teachers and support staff aspiring to a management position in a school board or college. Executives from both networks provided testimonials on their professional path.

The practical aspect of this training, the exchanges with experienced managers and the networking opportunities made possible, was greatly appreciated. Participants were able to learn more about the roles and responsibilities assumed by managers and to enhance their reflection process.

Co-development for co-ordination executives

In collaboration with the *Association des cadres des collages du Québec*, the AQCS organized a co-development group for co-ordinating executives working in school boards and CEGEPs. This activity brought together, during three non-continuous days, eight people who shared various concerns related to management situations, while reflecting on possible solutions. At the end of this activity, the participants noted that this collaborative effort largely contributed to the development of their professional practice.

Executive heads and administration officers

A committee composed of executive heads and administration officers was created in 2017-2018 to structure a relevant training offer. A day of professional development, resulting from these discussions, was structured and planned for March 20 and 21, 2019. Comments expressed by our members led the committee to postpone the training session until the fall of 2019. The content and the formula were revisited, in order to attract the interest of a maximum number of participants.



Works of the Collège des commissions professionnelles (College of Professional Boards)

Under the chairmanship of Ms. Julie Larouche, the *Collège des commissions professionnelles* held three meetings in 2018-2019. At the meeting of June 13, 2019, members exchanged views on the presentation and content of the 2019-2020 Action Plan to better reflect the mandates entrusted to the College. A meeting was scheduled to take place in the fall of 2019 to define the objectives that will make up this 2019-2020 Action Plan.

The AQCS head office team thanks the members of the College who, through their expertise and dedication, contribute to the professional development of school executives.

Works of the Professional Boards

The Professional Boards (PBs) regroup members of the same sector of activity. Their role is to promote the professional interests of members, to foster exchanges, to participate in the drafting of opinions and briefs and to serve on various committees.

Here are some achievements for the PBs in 2018-2019. Their respective action plans can be consulted at **www.aqcs.ca**.

- **PB of School Organisation:** This PB collaborated in the drafting of an opinion tabled by the AQCS in the framework of the parliamentary committee on the Bill no.12 (free education), as well as reflection points designated for Minister Jean François Roberge about school expenses borne by parents and the introduction of two 20-minute relaxation periods in schools.
- **PB of School Administration Services:** The personalized welcome of members is one of the priorities of this PBs Council. Several members have also agreed to join the Expertise Directory project, offering to share their professional experiences with colleagues who reach out to them.
- **PB of Procurement Services:** In order to better reflect the role and responsibilities of the school system's supply chain, the Professional Board of Procurement Services has changed its identity. From now on, it will be named the Professional Board of Procurement and Contract Management Services. In addition, this PB held a symposium on procurement and contract management in May 2019, in collaboration with partners. This first edition brought together 150 managers from the school, college and university networks. This new event replaces the annual Supply Day, which was the responsibility of this PB.



- PB of Financial Resources Services: This PB contributed to the drafting of several opinions for the AQCS, on budgetary rules, management of investment projects, Bill no.3 to introduce a single school tax rate and Bill No.12 on free education. For the benefit of its members, this PB updated the Tax Guide. This new tool was developed in collaboration with the Mallette group and takes the reality of school boards more specifically into account.
- **PB of Human Resources Services:** The Council of this PB conducted a survey on the evolution of the recruitment of new resources (professional, teaching and support staff), as well as an extensive consultation on the observations and practices in school boards. The results of this latest study formed the basis for an opinion on staff shortages, tabled in the fall of 2019. This PB also organized the first webinar for its members on copyright rules governing educational material developed by teachers. More than 60 people from the PB of Human Resources Services and the PB of General Secretariat and Communications participated.

- PB of Material Resources Services: To support the development of the skills of its members, this PB offered two additional training days as part of its annual refresher session. The members were invited to a presentation of the work related to the Lab-School and a custom training course entitled *«Les relations entre les commissions scolaires et les professionnels de la construction »*. The PB also supported the preparation and presentation to Minister Jean-François Roberge of recommendations aimed at improving the efficiency of school maintenance, the management of investment projects and the addition of spaces, and the AQCS opinion on the 2019-2020 budgetary rules.
- **PB of Educational Services:** This PB carried out a specific project on the census of the organization of pedagogical and complementary services in Quebec school boards. It also participated in the drafting of areas of reflection for Minister Jean-François Roberge about school expenses borne by parents, optimal management of educational services (in terms of a possible transformation of SBs) and Bill No.12 (free education).
- PB of Transportation Services: This PB has been invaluable in developing avenues for reflection on the two 20-minute relaxation periods in schools and the AQCS opinion on 2019-2020 budget rules.

- **PB of Information Technologies:** The simultaneous development sessions of the PB of Information Technoligies and the PB of of General Secretariat and Communications Services led to the organization of a first joint workshop under the theme *« Cyberattaques : simulation de cas et leçons à retenir »*. This proposal was well-received by participants and promoted the pooling of expertise.
- PB of General, Vocational and Business Training: The 3rd joint conference of the TRÉAQ and the PB of General, Vocational and Business Training was held on June 6 and 7, 2019, at the Lévis Convention and Exhibition Center. Out of 361 registrations, 213 participants were managers. During the conference, Mr. Serge Lacourcière, Director of the *Centres FP and FGA* of the Hauts-Bois-de-l'Outaouais SB, received this year's award of merit for a manager.
- **PB of General Secretariat and Communications Services:** This PB supported the drafting of the AQCS opinion on Bill no.12 (free education) and began updating the Annotated Education Act, a work in progress. On the occasion of the PB's development session, Mr. Érick Parent, Secretary-General and Director of Communications for the la Capitale SB, received the Emeritus School Executive Award for 2019 highlighting Mr. Parent's leadership and rigor.

Committee for the Professional Development of Executives and Managers

The arrival of a new government has caused significant delays in the payment of the grant. Unfortunately, we were unable to process the refunds quickly, since the grant was paid in June. The financial statement as of June 30, 2019 shows a surplus of approximately \$22.628. Like last year, the members of the committee agreed, after having obtained the authorization of the MEES, to allocate this sum to the further development of the Web *Clic Gestion* application as well as to its annual update. We would like to thank the members of the committee for their contribution to the achievement of the objectives set.

PUBLIC AND GOVERNMENT AFFAIRS

New Caquiste government

The theme *« Cadres scolaires : experts de la réussite »* was articulated by our representatives in 2017-2018. The purpose of this message was to make the newly elected government aware of the importance of including executives in all reflections affecting the education network: especially since the project of transforming school boards into school service centers has quickly become an objective of the Minister of Education and Higher Education, Jean François Roberge. Our arguments have largely focused on the provision of direct services to students deployed by managers and the desire of members to share their expertise.



Interventions in the education network

Mr. Jean-François Parent, President and CEO of the AQCS, was a speaker at the ACFAS Congress, May 27, 2019. He moderated a segment of a presentation under the theme *«La pertinence d'une meilleure collaboration nationale sur la recherche en éducation : mieux servir la pratique »*.

Mr. Parent was also invited to comment on manager profiles in the era of 4.0 at the conference of the *Association des cadres des collèges du Quebec*, November 8, 2018.

Survey about our communications tools

An online assessment survey of the internal and external communication tools of the AQCS was conducted from May 15 to 30, 2019. We obtained 408 responses, from, among others, 31 Section presidents.

- 75% of respondents prefer *InformAQCS* to be informed about AQCS affairs. This newsletter contributes to members' sense of belonging and the assurance that the AQCS team is working in their interests.
- Navigation on our website was rated 4/5.
- Lunchtime webinars, to address different issues, appealed to 82% of respondents.

Expertise Directory

In December 2018, AQCS members, wishing to share experiences or special knowledge, were invited to register in the AQCS *Répertoire des Expertise /* Expertise Directory. This new Web platform, accessible through our website, allows executives facing a professional challenge to find an ally within their AQCS network. Registered members offer support in the form of coaching, telephone interviews and meetings, among others.

21 members quickly registered as available resources. The communication strategy to publicize this tool will continue in 2019-2020.
